

## **OVERVIEW: NBCRNA BOARD OF DIRECTORS - CERTIFIED REGISTERED NURSE ANESTHETISTS**

The NBCRNA is seeking Certified Registered Nurse Anesthetist applicants for the NBCRNA Board of Directors. Applicants must be nurse anesthetists who have at least 5 years of clinical nurse anesthesia experience. Interested individuals should submit their application, curriculum vitae, and one letter of recommendation on or before December 13, 2023 to [nominations@nbcna.com](mailto:nominations@nbcna.com).

### **About the Director**

- Nurse anesthetist Directors will be elected either by certificants or by the NBCRNA Board. Regardless of how a Director is elected, he or she will serve as a full member of the NBCRNA Board of Directors with all rights and responsibilities. The Director will be asked to serve on at least one Board committee and may be assigned additional duties by the President.
- Upon completion of his or her term, the Director will be required to produce a report for the Board reflecting his or her experience as a Board member.
- The Director will be required to recognize and execute all fiduciary obligations to the NBCRNA.
- The duration of the Board position will be three (3) years, beginning October 2024 and ending September 2027.
- The Director may run for one additional term.
- This is a voluntary unpaid position.

### **Requirements**

- Applicant will be a CPC compliant nurse anesthetist with at least five years of nurse anesthesia experience.
- Certified Registered Nurse Anesthetists elected to the NBCRNA Board of Directors shall not have received material compensation from or served as a director, officer or employee of an organization with interests that are or may be in conflict with those of the NBCRNA for 12 months prior to being seated as a Director of the NBCRNA.
- Applicant will be an active member of the AANA.
- Prior experience in an activity sponsored by the NBCRNA (or its predecessor councils) that advances the mission of the NBCRNA (such as serving on a committee, task force, panel or worked as a consultant for the NBCRNA) in the last 10 years is preferred.

### **Selection Process**

Applicant information will be reviewed by the NBCRNA Leadership Development and Nominations Committee with input from the NBCRNA and AANA Board of Directors. Selected applicants will be interviewed by the Leadership Development and Nominations Committee and a ballot with three candidates will be presented to all CRNA certificants for election in late-February/early-March, 2024. The candidate who receives the most votes shall be asked to serve on the NBCRNA Board of Directors. In the event of a tie, a second election will be held.
