## **NBCRNA** Accreditation

## Patient-Centered - Supporting Lifelong Learning

The National Board of Certification and Recertification for Nurse Anesthetists (NBCRNA) is the nation's certifying body for initial, continued, and subspecialty board certification of the more than 61,000 Certified Registered Nurse Anesthetists (CRNAs). Our mission is to guard the well-being of the public by seeking to ensure that those who secure the CRNA credential have the necessary knowledge and skills to practice safely and effectively. We accomplish our mission through the development and implementation of credentialing programs that support lifelong learning among nurse anesthetists. We are a nonprofit organization and our CRNA and Nonsurgical Pain Management (NSPM-C) credential programs are accredited by both the National Commission for Certifying Agencies (NCCA) and the Accreditation Board for Specialty Nursing Certification (ABSNC)

NBCRNA credentialing provides assurances to the public that CRNAs have met objective, predetermined qualifications for providing nurse anesthesia services. A rigorous national entry process helps ensure that those who secure the CRNA credential enter the profession with the knowledge and demonstrated skills necessary to practice--however this is only the first step. Those who earn the credential dedicate themselves to lifelong learning. While state licensure provides the legal credential for the practice of professional nursing, private, voluntary certification indicates compliance with the professional standards for practice in this vital clinical nursing specialty.

### Mission

The mission of the NBCRNA is to promote patient safety through credentialing programs that support lifelong learning.

### Vision

The vision is to be recognized as the leader in advanced practice nurse credentialing.

## Supporting Lifelong Learning Through Nationally Accepted Standards

The credentialing programs of the NBCRNA are accredited by the National Commission for Certifying Agencies (NCCA) and the Accreditation Board for Specialty Nursing Certification, Inc. (ABSNC). NCCA accreditation means that the NBCRNA credentialing programs meet the highest national voluntary standards for private certification. NCCA accreditation validates the credential against the accepted standards across all credentialed professions. The NBCRNA received its initial accreditation from the NCCA in June 1984.

ABSNC accreditation means that the NBCRNA credentialing programs meet the standards of the only accreditation program for nursing specialties. It promotes the highest quality of specialty nursing practice through the establishment of standards of professional specialty nursing certification. When the NBCRNA received its initial accreditation from the ABSNC in August 1992, it was one of the first national certification bodies to be recognized and approved by the ABSNC.

In 2022, NBCRNA was re-accredited by the NCCA and the ABSNC for its CRNA and NSPM programs. Each program is re-accredited for the maximum five-year period.

## Letter From the President

This has been a milestone year in NBCRNA history. Although we have experienced challenges, 2023 has brought significant accomplishments and innovations.

From the outset of my tenure, the NBCRNA mission statement has been at the forefront of the Board of Director's (BOD) decision making; to promote patient safety through credentialing programs that provide lifelong learning. Working in tandem with the NBCRNA staff, we made progress in advancing the strategic objectives of NBCRNA, and I am truly appreciative of the work that both the BOD and NBCRNA staff have completed in 2023.

One of our most notable efforts was to encourage CRNAs to take the Continued Professional Certification Assessment (CPCA). The CPCA is a required component of the CPC Program, and CRNA's in their second four-year cycle are required to take the CPCA to renew their certification. The BOD and NBCRNA staff have worked tirelessly to ensure that CRNAs understand and successfully complete the requirements of the CPC Program and the necessary steps for certification renewal.

In 2023, 14,473 CRNAs completed the CPCA, which is an outstanding achievement for the organization and for the profession. When the entire profession engages in an assessment of their knowledge and demonstrates ongoing maintenance needed for safe practice, it sends a powerful and important message to the public we serve.

In 2024, many more CRNAs will need to complete their CPCA. We encourage CRNAs who are in their second four-year cycle to schedule their CPCA as early as possible so you can choose your preferred date, time, and modality (online or in-person).

Another mile-marker moment during my time as President was the completion of the Longitudinal Assessment Research Study. This ground-breaking research study explored the potential of Longitudinal Assessment (referred to as LA) to replace the CPCA as the assessment component for the CPC Program. NBCRNA's research team aimed to determine comparability in performance among participants who took the CPCA in its current single long form versus Lori Anderson DNP, MSN, CRNA, FAANA



those who engaged in an LA modality. The LA assessment participants answered 30-40 questions per calendar quarter, received immediate performance foodback and received rationalos

feedback, and received rationales and references for the questions.

From the start of the study, the BOD offered guidance to the NBCRNA research team, but we had full faith that they would be meticulous and steadfast in exploring the LA modality and provide accurate and detailed results to the BOD for decision-making. The outcome of the study was powerful, meaningful, and notably enhanced our understanding of adult learning principles. Together, we were able to forge a path forward for the CPC Program and CRNAs.

Based on the findings of the LA Research Study, the NBCRNA BOD made a strategic decision to move the assessment component of the CPC Program to an LA format for future CPC Program cycles. Beginning August 2024, an enhanced CPC Program will be launched, with the assessment portion of the program offering the LA modality to participants. Other CPC program enhancements were also approved by the BOD this year and you will be hearing about those improvements in the coming months.

Until the launch of the enhanced CPC Program, CRNAs will need to finish the requirements of their current CPC Program cycle (Class A, Class B, Core Modules, and the CPCA in its current form if applicable) before moving into the enhanced CPC Program.

Working together with the NBCRNA BOD and our Chief Executive Officer John C. Preston DNSc, CRNA, APRN, FAANA, FNAP, FAAN, has been an absolute pleasure, and I am honored to be a part of a team who is dedicated to furthering the CRNA profession. Dr. Preston and his entire staff at the NBCRNA are nothing short of remarkable. They are a visionary, cohesive team who strive to safeguard the CRNA credential and ensure that it remains an authoritative gold standard in advanced practice nursing certification.



Here are a few highlights from 2023 that I would like to touch on:

As previewed during AANA 2023 Annual Congress, NBCRNA announced the enhanced Continued Professional Certification (CPC) Program scheduled to begin in August 2024. After more than five-years of planning and a year-long research study amongst CRNAs, the CPC Program's assessment component is evolving to a longitudinal assessment (LA), replacing the once every eight years assessment. This update will better reflect how professional learning is lifelong and continuous, while also

from the CRNA community, including a streamlined program timeline and removal of Core Modules as a program requirement. These enhancements will go into effect after CRNAs complete their current requirements to renew their credential.

Finally, I am particularly honored to have been inducted as a Fellow of the American Academy of Nursing (FAAN). I was selected for my work in designing and establishing the first accredited post-graduate fellowship for Certified Registered Nurse Anesthetists in the field of advanced pain management.

2023 was a defining year for the NBCRNA. Seeing our staff and Board work tirelessly to ensure that we are moving in the right direction on behalf of our CRNA community is inspiring. I sincerely appreciate the commitment to continuous learning that the NBCRNA promotes both externally to CRNAs, as well as internally among our own staff. The future is bright for nurse anesthesia credentialing and we are laying the foundation for future landmark moments for all CRNAs.

## NBCRNA 2023 Board of Directors

The NBCRNA is managed by a Board of Directors who are recognized as leaders in nurse anesthesia and related fields. The members of the Board are comprised of certified registered nurse anesthetists, as well as a board-certified surgeon and anesthesiologist, both of whom have a current working relationship with nurse anesthetists, and a representative of the public at large. ## Lori Anderson, DNP, MSN, CRNA, FAANA

Dr. Lori Anderson is an Associate Professor, and the Chair/Program Director for the Department of Nurse Anesthesia at Rosalind Franklin University, North Chicago, IL. Lori earned her BSN and MSN from Northern Illinois University, and her DNP from Rush University. She was a past president of the Illinois Association of Nurse Anesthetists and a past member of the Illinois Board of Nursing.

### Vice President Susan McMullan, PhD, CRNA, CNE, CHSE, FAANA, FAAN

Dr. Susan McMullan is an Associate Professor and Director, BSN-DNP Pathway in Nurse Anesthesia at the University of Alabama at Birmingham (UAB) School of Nursing. She earned her BSN from University of Michigan, her MSN in Nurse Anesthesia from Rush University, and her PhD from Rutgers, the State College of New Jersey. Prior to her move to Birmingham, she worked full time as a clinical CRNA in Chicago. In her time at UAB, she has received over \$500,000 in Nurse Anesthesia Traineeship and AANA Foundation Research Grants. She also developed the only anesthesia workload instrument and was key in increasing the number of CRNAs in Alabama during a critical workforce shortage. She has been inducted as a Fellow of both the American Association of Nurse Anesthesiology and the American Academy of Nursing. In 2019 she received the Alabama Association of Nurse Anesthetists (ALANA) Outstanding Advocacy and Service to the CRNA Profession Award for her dedication to the profession. Susan maintains a clinical faculty practice at UAB Callahan Hospital.









## Secretary/Treasurer Garry Brydges, PhD,

Dr. Garry Brydges is the Director of Quality and Outcomes in Anesthesia and the former chief nurse anesthetist for 17 years at MD Anderson Cancer Center in Houston, Texas. Currently, his work includes a subdomain in artificial intelligence known as neural network machine learning for developing a perioperative oncologic collaborative registry. He is adjunct faculty at the University of Texas and Baylor College of Medicine Nurse Anesthesia Programs, Texas Woman's University Nursing Graduate Programs, and adjunct professor at Case Western Reserve University - Shaughnessy Nurse Leadership Academy. Garry graduated from the University of Texas Nurse Anesthesia Program and was the recipient of the Agatha Hodgins Outstanding Graduate Award. He has an extensive academic background also graduating from the University of Texas Acute Care Nurse Practitioner Program before nurse anesthesia training, concentrating in cardiovascular surgery. He completed his DNP at Texas Christian University in 2011, focusing research in Preoperative Considerations for the Heart Failure Patient with Cardiac Resynchronization Therapy. Other degrees include an Executive MBA, Masters in Healthcare Administration, as well as a PhD in Financial Management and Economics in Healthcare Delivery, at Texas Woman's University. In 2021, he was recently inducted as an inaugural fellow of the American Association of Nurse Anesthetists for his leadership nationally and globally contributing to the nurse anesthesia profession. He completed his term in 2019 as the 79th President of the American Association of Nurse Anesthetists. He was the President of the Texas Association of Nurse Anesthetists from 2012-2013.

Her time at Lurie Children's Hospital has been one of promotion and expansion, growing the team from 0 to 26 CRNAs. Dr. Rosenblatt supported development at Lurie within pediatric subspecialties creating dedicated teams for pediatric cardiac anesthesia in the Lurie Heart Center and maternal-fetal anesthesia within the Chicago Institute for Fetal Health. An advocate for clinical education, Lurie is the pediatric anesthesia training site for the Chicagoland CRNA programs. Lurie received accreditation from the COACRNA for a CRNA pediatric anesthesia fellowship in 2021 and Dr. Rosenblatt serves as the director. She is an assistant professor in Rush's College of Nursing and serves as the assistant program director of didactic education in the nurse anesthesia program track. Her research expertise is in qualitative methods, with a focus on medical decision-making and well-being during clinical education.



## **Emerging Leader Fellows**



He has published numerous articles in testing-related scientific journals and has been a regular presenter at meetings of the National Council on Measurement in Education, the Association of Test Publishers, and the Institute for Credentialing Excellence, among others. Prior to returning to the NBCRNA, He most recently served in the role of Senior Director, Psychometrics and Testing, with the Board of Pharmacy Specialties.

## **Continued Professional Certification (CPC) Program**

The CPC Program supports lifelong learning and the strong CRNA credential, protecting your ability to continue practicing as a CRNA. It is designed to meet the Advanced Practice Registered Nursing (APRN) regulatory reguirements of every state Board of Nursing.

The program also reinforces the validity and value of your CRNA credential, demonstrating to your patients, their families, and your employer that you meet the credentialing requirements designed to promote lifelong learning, help you maintain current anesthesia knowledge, and encourage patient safety- even as the health care environment constantly changes.

## The Continued Professional Certification Assessment (CPCA)

As CRNAs move through the current CPC Program, they continue to take the CPCA, a performance standard assessment. The 150-question assessment covers knowledge in the four core domains of nurse anesthesia practice, has a three-hour time limit and may be taken at a testing center or at home under remote-proctor conditions. The CPCA is not a pass/fail exam, but rather can be used as a self-assessment.

### In 2023, 14,473 CRNAs took their CPCA.

The CPCA needs to be completed during a CRNA's second four-year cycle. As soon as a CRNA is in the second four-year cycle, they are eligible to take the CPCA. The deadline for the CPCA is six months before a CRNA's credential renewal deadline. We encourage all CRNAs to complete their CPCA as soon as they are ready.

The CPCA assesses knowledge in the four core domains of nurse anesthesia practice:

- Airway Management
- Applied Clinical Pharmacology
- Human Physiology and Pathophysiology
- Anesthesia Equipment and Technology

## **Enhancing the CPC Program Experience**

As previewed during NBCRNA's update at the AANA 2023 Annual Congress, NBCRNA is making enhancements to the Continued Professional Certification (CPC) Program for 2024. The enhancements, based on CRNA feedback to the current program and evaluating alternative programs and assessment approaches, better reflect how professional learning is lifelong and continuous when delivering safe, quality anesthesia care.

CPC Program updates will include:

- Streamlined Program Timeline: The overall program will have a simplified four-year certification cycle timeline, where all components are the same for every four-year cvcle.
- Reduction in Program Components: Core Modules will no longer be a program requirement. Note: CRNAs can still take "Core Module Courses" by approved providers as a part of Class A Continuing Education Credits, which will continue to be a requirement for the CPC Program as well as Class B Professional Activities Credits.
- Convenience in Assessing Knowledge: A revised assessment approach - Continued Professional Certification Longitudinal Assessment (CPC-LA) - that provides a series of multi-choice and multi-select guestions every guarter conveniently on your computer or mobile device via a new mobile app. Throughout the CPC-LA, CRNAs will receive immediate feedbackexplaining the rationale of answers and recommending knowledge areas for further professional development.

CRNAs will begin to be notified about when they enter the enhanced CPC Program with more specifics about the program throughout 2024 and 2025.

Although changes are planned for the future of the CPC Program, CRNAs are required to fulfill their current cycle requirements to renew their credential before they are enrolled in the enhanced CPC Program.





## Credentialing Research

## **NBCRNA** Portal Improvements

## Longitudinal Assessment Research Study Completed in 2023

In 2021, the NBCRNA Board of Directors approved a new research study to explore the potential of longitudinal assessment (LA). LA, as compared to a single large assessment, processes the ability to spread shorter assessments of specific content over a long period of time to help build understanding, knowledge and confidence.

In February 2022, a call for volunteers was sent to all eligible CRNAs to participate in the research study. 1,000 CRNAs were selected, and those selected are representative of the CRNA population, and randomly assigned one of two conditions: CPCA in its current form or in its LA configuration. The study began on April 4, 2022, and concluded March 31, 2023.

The outcome of the research study revealed that LA is not only feasible but also preferable. Despite minor differences in performance metrics, both groups (CPCA in its current form and the LA configuration) expressed high satisfaction and the LA group displayed a higher mean scaled score and improved performance on repeated questions. The results of the study underscore the value of LA, offering flexibility for busy professionals and promoting lifelong learning.

In June 2023 based on the findings of the LA Research Study, the NBCRNA Board of Directors made the strategic decision to move the assessment component of the CPC Program to a LA format for future CPC Program cycles based on the findings of the LA Research Study.

In 2024, NBCRNA is launching an enhanced CPC Program to support the ongoing learning and knowledge of CRNAs, which will include the Continued Professional Certification Longitudinal Assessment (CPC-LA). More details about the enhanced CPC Program can be found at WWW NBCRNA COM/ENHANCEDCPC

## Derrick C. Glymph, PhD, DNAP, CRNA, CHSE, COL., AN, **USAR, FAANA, FAAN**




## **Emerging Leader Fellow** Terrica Harris, MSNA, CRNA

## **Advancing The Profession: Initial Certification**

Each year, the NBCRNA administers various examinations including the Self-Evaluation Examination (SEE) for nurse anesthesia students, the National Certification Examination (NCE) to enter the profession, and the subspecialty Nonsurgical Pain Management Certification (NSPM-C) Examination.

## **National Certification Examination (NCE)**

Candidates in the 137-nurse anesthesia educational programs throughout the United States sit for the NCE, which requires a passing score to become a CRNA. The NBCRNA administers the NCE to measure the knowledge necessary for entry-level nurse anesthesia practitioners.

From January 1, 2023, through December 31, 2023, a total of 3,613 NCE's were administered; 3,008 candidates were first-time takers with a pass rate of 83.2%. There was a total of 605 repeat administrations of the exam with an overall pass rate of 60.8%. A list of newly certified CRNAs by state of residence is published monthly on the NBCRNA website.

## **NCE Exit Survey Results**

The NBCRNA strives to uphold our customer service commitment to excellence. Overall satisfaction remains high.

From January 1, 2023, through December 31, 2023:

98.15% of NCE candidates were satisfied with the NBCRNA testing experience.



## Self-Evaluation Examination (SEE)

The SEE is an important part of the preparatory process to become a CRNA. The SEE is a voluntary examination with three objectives: to provide information to students about their progress in the nurse anesthesia educational program; to provide information to program administrators on how well their programs are preparing students with the knowledge they need for anesthesia practice; and to prepare students for NCE experience. From January 1, 2023, through December 31, 2023, a total of 6,361 candidates took the SEEs.

## **SEE Predictability**

The NBCRNA strives to support SRNAs in their journey to become a CRNA. During their education program, student are eligible to take the SEE, which provides insights into their preparedness for the NCE to enter the profession. Each year, a predictability study is conducted on the SEE t gauge predictability in projected performance on the NCE.

· According to the SEE survey, 84.14% of individuals who took the SEE agreed that it helped prepare them to take the NCE.

## **Subspecialty Certification: Nonsurgical Pain** Management (NSPM) Continues Growth in 2023


Since inception of the NSPM Program through December 31, 2023, 208 CRNAs have earned the NSPM-C credential, 33 of which were achieved in 2023. The NBCRNA's NSPM program was initially developed in 2015 in response to challenges continually faced by nurse anesthetists who practice nonsurgical pain management. The NBCRNA subspecialty certification for nurse anesthetists measures the knowledge, skills and abilities of CRNAs for practice in the field of nonsurgical pain management. A list of new CRNA NSPM-Certificants is published on the NBCRNA website following each exam testing window.


