ABOUT THE NBCRNA

Patient-Centered, Supporting Lifelong Learning

The National Board of Certification and Recertification for Nurse Anesthetists (NBCRNA) is the nation's certifying body for initial, continued, and subspecialty board certification of the more than 55,000 Certified Registered Nurse Anesthetists (CRNAs). Our CRNA and Nonsurgical Pain Management (NSPM-C) credential programs are accredited by both the National Commission for Certifying Agencies (NCCA) and the Accreditation Board for Specialty Nursing Certification (ABSNC).

NBCRNA credentialing provides assurances to the public that CRNAs have met objective, predetermined qualifications for providing nurse anesthesia services. A rigorous national entry process helps assure that those who secure the CRNA credential enter the profession with the knowledge and demonstrated skills necessary to practice—however this is only the first step. Those who earn the credential dedicate themselves to lifelong learning. While state licensure provides the legal credential for the practice of professional nursing, certification indicates compliance with the professional standards for practice in this vital clinical nursing speciality.

NBCRNA ACCREDITATION

Enhancing the Value of the Credential Through Nationally Accepted Standards





The credentialing programs of the NBCRNA are accredited by the National Commission for Certifying Agencies (NCCA) and the Accreditation Board for Specialty Nursing Certification, Inc. (ABSNC). NCCA accreditation means that the NBCRNA credentialing programs meet the highest national voluntary standards for private certification. NCCA accreditation validates the credential against the accepted standards across all credentialed professions The NBCRNA received its initial accreditation from the NCCA in June 1984.

ABSNC accreditation means that the NBCRNA credentialing programs meet the standards of the only accreditation program for nursing specialties. It promotes the highest quality of specialty nursing practice through the establishment of standards of professional specialty nursing certification. When the NBCRNA received its initial accreditation from the ABSNC in August 1992, it was one of the first national certification bodies to be recognized and approved by the ABSNC. In 2018, the NCCA and ABSNC approved the reaccreditation of the NBCRNA certification program and the Continued Professional Certification (CPC) Program through July 2022. The NBCRNA's Nonsurgical Pain Management (NSPM-C) subspecialty certification program was granted accreditation by the ABSNC in August 2017, and in 2018 was granted accreditation by the NCCA.

Together, NCCA and ABSNC accreditation provides a strong and widely accepted standard for the nurse anesthetist credential that has been institutionalized in many position descriptions as a practice requirement or as a standard for demonstrating equivalency. It has been recognized in state nurse practice acts and state rules and regulations.

A LETTER FROM THE PRESIDENT

As an organization, NBCRNA also stayed strong, renewing our three Strategic Plan goals to guide our work. We also welcomed three new CRNA members to the Board, along with one anesthesiologist member, each bringing depth, new perspectives, and experience to NBCRNA's Board work. They are Garry J. Brydges, Ph.D., DNP, MBA, ACNP-BC, CRNA, FAAN; Robert T. Laird, CRNA; and Lisa M. Riedel, DNP, MS, CRNA along with Sara Gonzales, MD, DABA. They began their three-year terms in October 2020. Compounding a challenging year, or perhaps in part provoked by it, our country saw an uprise in racial unrest not seen in years. The NBCRNA issued a statement emphasizing the value we place on diversity, noting how we have long felt responsible for contributing professionally to building a health care community of equal opportunity. We saw how the COVID-19 pandemic highlighted healthcare disparities within our society related to outcomes and race. NBCRNA's mission is to protect patient safety by enhancing provider quality, including all patients of all backgrounds, and speaks directly to our core values.

As 2020 wore on, the CRNA profession realized it is not pandemic-proof as we witnessed the cancellation of elective surgeries, for example. Yet because of our strong CRNA credential, we could flex our skills in other areas. Our training and commitment to quality enabled us to showcase our value add, marking our profession's pivotal time.

As we reflect on the life-changing events of 2020, we look forward to brighter days in 2021.

A MESSAGE FROM THE CEO



Karen Plaus, PhD, CRNA, FAAN, CAE NBCRNA Chief Executive Officer

This was a challenging year to say the least for all of usboth personally and professionally. For the NBCRNA, it also marked several milestones, beginnings and endings. We saw our strong CRNA credential leveraged and our scope of practice expanded to provide support on the health care front lines throughout the pandemic. Like many organizations and individuals in 2020, NBCRNA embraced agility. Yet, we kept our mission and strategic goals at the forefront to guide us steadily through the disarray that was 2020.

Research remained a key focus for the NBCRNA. To benchmark CRNAs' perceptions of value, satisfaction and quality of the CRNA credential, NBCRNA launched a nationwide survey to all active CRNAs in February. We engaged RTI International to conduct the nationwide survey to gain an understanding of CRNA perceptions of the value of the CRNA credential. This Value of the Credential survey indicated that despite varied work environments, the profession being identified as a high-stress occupation, and legislation impacting scope of practice, an extremely high percentage of CRNAs are personally satisfied with their profession choice, are proud to have obtained the CRNA credential, and indicated that it gives them greater job satisfaction. The survey provided a valuable baseline for better understanding CRNA views on the credential to inform strategic decisions and will be used in future studies for benchmarking and trending over time.

The pandemic also took its toll on testing facility availability, impacting nurse anesthesia students' ability to schedule and take their National Certification Examination (NCE). NBCRNA worked with our testing facility partners to secure additional testing seats and locations. Additionally, US Military Base testing sites were also added to expand opportunities for taking the National Certification Examination and the Self-Evaluation Examination.

Showcasing our position as a leader in the credentialing field, NBCRNA was honored to be awarded the Janel Parker President's Award for Credentialing Excellence by the Institute for Credentialing Excellence. The NBCRNA was recognized with this award for its commitment to excellence in certification, research to advance certification, and NBCRNA's visionary programs.

Two CPC Program-related initiatives also debuted in 2020. A pilot of the CPC Assessment component of the CPC Program was conducted to ensure a smooth launch of this requirement beginning in 2021. This year also marked the first 4-year certification renewal cycle in the CPC Program since its launch in 2016. Because of the impact on continuing education opportunities due to the pandemic, the NBCRNA extended the July 31, 2020 certification renewal deadline by four months to November 30, 2020, to allow additional time to complete any needed credits.

Lastly, this year marked another milestone as I announced my plan to retire as CEO in August 2021. The Board of Directors initiated its CEO succession plan and I will remain in my current role as CEO through the transition. After a 15year career leading the NBCRNA through incorporation and the launch of a new certification renewal program, among other advancements, I am confident that it is the right time to transition the organization to its next generation of leadership. Serving NBCRNA alongside our growing staff, Board of Directors, the hundreds of volunteers, and on behalf of the over 55,000 Certified Registered Nurse Anesthetists, has been my great privilege and the highlight of my professional career. I am extremely proud of all that we have accomplished to position NBCRNA as the leader in advanced practice nurse credentialing. As we look to transition to the next chapter in 2021, I have great confidence in the strength of our team and the opportunity ahead for NBCRNA.

I will continue to be a proud part of this amazing CRNA community and profession.

The NBCRNA is managed by a Board of Directors who are recognized as leaders in nurse anesthesia and related fields. The members of the Board are comprised of certified registered nurse anesthetists, as well as a board-certified surgeon and anesthesiologist, both of whom have a current working relationship with nurse anesthetists, and a representative of the public at large. Members of the Board are elected to serve staggered three-year terms. Two non-voting Emerging Leader Fellows also participate on the Board of Directors as part of the Fellowship.

Survey Shows CRNAs are Highly Satisfied with the Profession Choice Despite Challenges

In February 2020, the NBCRNA engaged RTI International to conduct a nationwide survey of more than 55,000 Certified Registered Nurse Anesthetists (CRNAs) to gain an understanding of CRNA perceptions of the CRNA credential. More than 10,000 CRNAs responded to the Value of the Credential (VOC) survey, providing important insights.

This first phase of the multi-phase Value of the Credential study indicated that despite the various work environments, the profession being identified as a high-stress occupation, and legislation impacting scope of practice, an extremely high percentage of CRNAs are satisfied with being a CRNA, are proud to have obtained the credential, and indicated that it gives them greater job satisfaction.





NBCRNA Celebrates Nurses Month 2020!

This year, National Nurses Week was extended to a monthlong celebration during the entire month of May to expand opportunities to elevate and celebrate nursing. Given the prominent role nurses were to play in the

coming months during the COVID-19 pandemic, this longer celebration was especially appropriate. The celebration is a time "to recognize the vast contributions and positive impact of America's four million registered nurses," according to the American Nurses Association. Certified Registered Nurse Anesthetists (CRNAs) safely administer approximately 43 million anesthetics to patients each year in the United States, according to the American Association of Nurse Anesthetists (AANA). Today, over 55,000 professionals hold the nurse anesthetist certification in the United States and practice in every type of setting requiring anesthesia, from delivery rooms and dental offices to operating rooms and outpatient surgical centers.

NBCRNA CREDENTIALING RESEARCH

NBCRNA's research initiative allows us to leverage today's technologies and research to continue to develop the evaluation of the current NBCRNA credentialing programs, and investigation of the question: What are optimal* ways to assess and maintain knowledge? From a multi-phase nationwide CRNA survey on the Value of the Credential to the addition of a fifth subcommittee, research is helping to guide the work of the NBCRNA on behalf of the nurse anesthetist profession. Research and technologies will continue to impact CRNA practice in various ways over the coming years and the NBCRNA is committed to research in determining optimal* ways to assess and maintain the knowledge needed for initial and continued board certification over time in CRNA practice. *evidence-based, valid, reliable, feasible, desirable, and viable



The Evaluation and Research Advisory Committee (ERAC)

The NBCRNA Evaluation and Research Advisory Committee (ERAC) is responsible for developing an evidencedbased evaluation of all recommendations related to the credentialing programs to help inform the NBCRNA. In 2020, the ERAC spearheaded the Value of the Credential (VOC) study. Through its work like the VOC study, the committee assists the board in providing oversight for project development and design, ongoing analysis, outcomes, and reports related to the NBCRNA's credentialing programs.

Fifth ERAC Subcommittee Established

As part of this ongoing work, the NBCRNA's ERAC established a fifth subcommittee in 2020 to focus on research specific to credential value and satisfaction. The subcommittees now include:

VALUE AND SATISFACTION SUBCOMMITTEE:

Added in 2020: This subcommittee was formed to investigate how to measure and evaluate value and satisfaction of the Certified Registered Nurse Anesthetist (CRNA) credential.



SIMULATION-BASED CPC ASSESSMENT

SUBCOMMITTEE: This subcommittee was established to explore innovative simulation modalities and determine what role, if any, they may play in NBCRNA credentialing programs (i.e., screen-based simulation, extended reality, oral exams, and as well objective structured clinical examination).



METHODS TO ASSESS KNOWLEDGE AND COMPETENCE SUBCOMMITTEE: This subcommittee was formed to explore current and

innovative methods for assessment of CRNAs' crucial clinical decision-making knowledge, judgement, and skills throughout their career. These methods include: Simulation, Longitudinal Assessment, and Virtual Reality – Gaming. The subcommittee has completed their work and are developing a final report.



LONGITUDINAL ASSESSMENT

SUBCOMMITTEE: This subcommittee was formed to investigate the use of longitudinal assessment as an alternative or option to the CPC Assessment and throughout NBCRNA's credentialing programs.



ENGLISH AS A SECOND LANGUAGE (ESL) SUBCOMMITTEE: This

subcommittee was formed to explore considerations on examination performance for examinees with English as a second language (ESL) and Limited English proficiency (LEP) and provide recommendations to the NBCRNA Board of Directors.

NBCRNA CREDENTIALING RESEARCH

Value of the Credential Survey Conducted Results Published Fall 2020

As part of NBCRNA's strategic priority, a multi-phase research initiative on the Value of the Credential (VOC) was launched through a survey to collect data from the population of Certified Registered Nurse Anesthetists (CRNAs) on their perceived value of the CRNA credential.

The purpose of this baseline survey was to obtain a better understanding of CRNA perceptions on the value of the credential, holistically, throughout their career and not on any specific credentialing program. Overall, the findings from the VOC survey revealed that CRNAs have a highly favorable view of the credential. More than 10,000 CRNAs responded to the survey, providing important insights. Phase I of this multi-phase project focuses on benchmarking and better understanding perceived value of the CRNA credential by the CRNA community. NBCRNA Chief Research Officer Dennis Spence, PhD, MS, CRNA, FAAN, noted that upcoming phases of the Value of the Credential survey will look more closely at the CPC components and process for further evaluation.

The survey provided NBCRNA with a valuable baseline for better understanding CRNA views on the credential to inform strategic decisions and will be used in future studies for benchmarking and trending over time.

NBCRNA CREDENTIALING RESEARCH

NBCRNA Completes CPC In-Person and Remote Online Proctored Pilot

The NBCRNA launched a pilot study for the CPC Assessment (CPCA) using two testing conditions: in-person at testing centers and remotely using online proctoring. A total of 314 candidates completed in-person testing in February 2020 and 220 completed testing via remote online proctoring in August 2020.

The Remote Online Proctored Pilot featured online testing with a record and review component. This means that all sessions were reviewed by trained vendor staff and any areas of question or concern were flagged for NBCRNA review and final decision. There were no testing performances that were determined to be in violation of NBCRNA's rules of conduct for the pilot. This pilot effort provided the NBCRNA with valuable insights beyond the test scores of the participants. The pilot concluded in August 2020, followed by data analysis and finalized scoring.

CONTINUED PROFESSIONAL CERTIFICATION (CPC) PROGRAM

CPC Cycle Deadline Extended Four Months Due to Pandemic

During 2020, more than 20,000 CRNAs finished their first four-year cycle of the Continued Professional Certification (CPC) Program and successfully completed the first certification renewal since the launch of the program in 2016. With the onset of the COVID-19 pandemic in early 2020, the NBCRNA extended the July 31, 2020 certification renewal deadline by four months to November 30, 2020, allowing additional time to fulfill the CPC requirements.*



Looking Ahead: The Continued Professional Certification Assessment (CPCA)

CRNAs will begin taking the CPCA, a performance standard assessment, beginning in 2021. The 150 multiple choice assessment covers knowledge in the four knowledge domains of nurse anesthesia practice, has a three-hour time limit, and may be taken at a testing center or at home under remote-proctor conditions. The CPCA is not a pass/fail exam, but rather can be used as a self-assessment.

CRNAs Take on the Front Lines: COVID-19



ADVANCING THE PROFESSION

The CRNA credential is the gold standard board certification for advanced practice registered nurses, who are experts in the field of anesthesia. The credential is awarded to those who demonstrate the necessary knowledge, skills, and abilities to deliver quality, safe, effective, reliable anesthesia care.

The high standards for achieving and maintaining the CRNA credential instills confidence among certificants in their professional ability to provide safe, individualized care to the patients they serve.

As a guardian of public safety, the NBCRNA is dedicated to protecting the integrity of the exams which are an integral part of nurse anesthesia training. This dedication benefits both patients and nurse anesthetists.

Each year, NBCRNA administers various examinations including the Self-Evaluation Examination (SEE) for nurse anesthesia students, the National Certification Examination (NCE) to enter the profession, and the subspecialty Nonsurgical Pain Management Certification (NSPM-C) Examination.

National Certification Examination

Each year, candidates in the 124 nurse anesthesia educational programs throughout the United States sit for the National Certification Exam (NCE), which requires a passing score to become a Certified Registered Nurse Anesthetist (CRNA). The NBCRNA administers the NCE to measure the knowledge necessary for entry-level nurse anesthesia practitioners.

From January 1, 2020 through December 31, 2020, the number of NCE candidates testing increased over the previous year despite pandemic constraints. There were a total of 3,130 NCE administrations; 2,630 candidates were first-time takers with a pass rate of 85.2%. A list of newly certified CRNAs by state of residence is published monthly on the NBCRNA website.

Self-Evaluation Examination

The NBCRNA Self-Evaluation Examination (SEE) is an important part of the preparatory process to become a CRNA. The SEE is a voluntary examination with three objectives: to provide information to students about their progress in the nurse anesthesia educational program; to provide information to program administrators on how well their programs are preparing students with the knowledge they need for anesthesia practice; and to prepare students for the National Certification Examination (NCE) experience. From January 1, 2020 through December 31, 2020, a total of 4,450 candidates took the Self-Evaluation Examination.

SEE Predictability

The NBCRNA strives to support Student Registered Nurse Anesthetists (SRNAs) in their journey to become a CRNA. During their education program, students are eligible to take the SEE, which provides insights into their preparedness for the NCE to enter the profession. Each year, a predictability study is conducted on the SEE to gauge predictability in projected performance on the NCE.

- According to the SEE survey, 95.6% of individuals who took the SEE agreed that it helped prepare them to take the NCE.
- An analysis of 2020 SEE and NCE performance showed that, similar to previous years, a clear, positive correspondence exists between the SEE scores and the NCE scores. This information is especially important for nurse anesthesia educational programs to identify how their program is preparing students for the NCE, the examination required to enter the profession.

NBCRNA Launches New Test Center Opportunities for Military in 2020

Periodically, nurse anesthesia students are deployed soon after completing their nurse anesthesia educational program, as are civilian students who have post-graduation commitments with the armed services, and active-duty service in our military programs. In these cases, the graduate may experience a significant delay in being able to take their National Certification Examination following deployment.

To reduce the incidence of this delay, NBCRNA worked with Pearson VUE testing center representatives during 2020 to provide National Certification Examination (NCE) and Self-Evaluation Examination (SEE) testing access to active duty military at select US military base sites. The military testing channel went live on June 29, 2020 and supports SEE/NCE testing needs at select US military bases in Europe, the Middle East, Asia and the Pacific. Onbase testing provides defense employees with the opportunity to conveniently test where they serve, diminishing the delay, cost and interruption associated with arranging state-side testing if or when that option is available.

Subspecialty Certification: Nonsurgical Pain Management (NSPM-C) Continues to Grow

Since inception of the NSPM Program through December 31, 2020, 105 CRNAs now hold the NSPM-C credential, 28 of which were achieved in 2020. The NBCRNA's NSPM program was initially developed in 2015 in response to challenges continually faced by nurse anesthetists who practice nonsurgical pain management. The NBCRNA subspecialty certification for nurse anesthetists measures the knowledge, skills, and abilities of CRNAs for practice in the field of nonsurgical pain management. ERAC Subcommittee Members Present Virtual Posters at the 2020 American Academy of Nursing Virtual Conference

The "Assessment During Recertification: A Scoping Review" poster was presented by Kenneth A. Wofford, PhD, CRNA, Kay Sanders, DNP, CRNA, and Edwin Aroke, PhD, CRNA, and discussed how there are limited studies on the assessment of Knowledge, Skills, and Abilities (KSAs) or clinical performance in non-physician providers and that only a few studies report on the use of novel methods such as gaming, longitudinal assessment, or simulation. Recertification organizations, especially for advanced practice nurses, should prioritize and incentivize research programs to close these knowledge gaps and ground future recertification programs on substantial evidence.

The "NBCRNA Pilot: Simulations in Lieu of Recertification Exam" poster reviewed and addressed simulation as an alternative to the existing 150-item multiple choice question (MCQ) CPCA. This poster was presented by Suzie Kardongh-Edgren, PhD, RN, ANEF, CHSE, FSSH, FAAN, Virginia "Chris" Muckler, DNP, CRNA, CHSE-A, FAAN, and Michele Abersol, PhD, RN, CHSE, FAAN.


I.C.E. EXCHANGE PANEL: COMMUNICATING THE IMPORTANCE OF CERTIFICATION TO THE PUBLIC
