ABOUT THE NBCRNA: STRATEGIC PLAN

The National Board of Certification and Recertification for Nurse Anesthetists (NBCRNA) is the nation's certifying body for the initial and continued certification of the 55,000 Certified Registered Nurse Anesthetists (CRNAs) practicing in every practice setting in the U.S. Our primary responsibility is to guard the well-being of the public by seeking to ensure that those who secure the CRNA credential have the necessary knowledge and skills to practice safely and effectively. We accomplish our mission through the development and implementation of credentialing programs that support lifelong learning among nurse anesthetists.

NBCRNA credentialing provides assurances to the public that CRNAs have met objective, predetermined qualifications for providing nurse anesthesia services. While state licensure provides the legal credential for the practice of professional nursing, private, voluntary certification indicates compliance with the professional standards for practice in this clinical nursing specialty.

The primary goal of the NBCRNA is to protect the well-being of the public by seeking to ensure that nurse anesthetists have the necessary knowledge and skills to practice safely and effectively. In so doing, we also protect the value of the CRNA credential.

The mission of the NBCRNA is to promote patient safety through credentialing programs that support lifelong learning.

The vision of the NBCRNA is to be recognized as the leader in advanced practice nurse credentialing.

ACCREDITATION

ENHANCING THE VALUE OF THE CREDENTIAL THROUGH NATIONALLY ACCEPTED STANDARDS





The credentialing programs of the NBCRNA are accredited by the National Commission for Certifying Agencies (NCCA) and the Accreditation Board for Specialty Nursing Certification, Inc. (ABSNC). NCCA accreditation means that the NBCRNA credentialing programs meet the highest national voluntary standards for private certification. NCCA accreditation validates the credential against the accepted standards across all credentialed professions.

The NBCRNA received its initial accreditation from the NCCA in June 1984. ABSNC accreditation indicates that the NBCRNA credentialing programs meet the standards set by the only nursing accreditation body for nursing specialties. It promotes the highest quality of specialty nursing practice through the establishment of standards of professional specialty nursing certification. When the NBCRNA received its initial accreditation from the ABSNC in August 1992, it was one of the first national certification bodies to be recognized and approved by the ABSNC. In 2018, the NCCA and ABSNC approved the reaccreditation of the NBCRNA certification program and the Continued Professional Certification (CPC) Program through July 2022. The NBCRNA's Nonsurgical Pain Management (NSPM-C) certification program was granted accreditation by the ABSNC in August 2017, and in 2018 was granted accreditation by the NCCA.





Together, NCCA and ABSNC accreditation provides a strong and widely accepted standard for the nurse anesthetist credential that has been institutionalized in many position descriptions as a practice requirement or as a standard for demonstrating equivalency. It has also been recognized in state nurse practice acts and state rules and regulations.

Our extensive Beta Research Study on the CPC Assessment, along with a national Benchmarking Study, led to the announcement in 2019 of two significant changes to the CPC Assessment: the removal of the pass/fail requirement and allowing the option for the assessment to be taken remotely at home or at a testing center.

We want to ensure we have strong leaders and volunteers who can help us realize the vision of the NBCRNA to be the leader in advanced practice nurse credentialing. One of the goals of the Board of Directors was to support research that looks at the value and validity of our work in credentialing. This year, we established four subcommittees of the Evaluation and Research Advisory Committee to provide additional data and discovery in key areas including looking at methods to assess knowledge and competence, longitudinal assessment and simulation-based CPC Assessment, and exploring the impact of English as a second language as it relates We continue to enhance the Continued Professional Certification (CPC) Program based on research, data, and feedback from CRNAs and other stakeholders to make the program relevant to and supportive of the entire CRNA community.

Over the past year, the NBCRNA was also proud to have supported the CRNA profession through donations, grants and sponsorships within the CRNA profession for students, the military, our continued support of the diversity initiative, and of other organizations like the AANA that help advance the profession.

We look forward to a strong future for our wonderful profession, ensuring the continued and unquestioned integrity of the CRNA credential.

Not only are we committed to credentialing research, but also sharing data with other organizations. The NBCRNA's Beta Research Study on the CPC Assessment was published in the Journal of Nursing Regulation, and the research was also shared in the AANA State of the Science Poster Session at the AANA 2019 Annual Congress. Board members and staff also helped organize a Simulation conference at Harvard University for a deep dive into advances in simulation-both the technology and applications for the CRNA credential and profession.

NBCRNA: FOCUS ON THE CREDENTIAL

Value Statement The NBCRNA was created in recognition of the importance the nurse anesthetist profession places on patient safety. Our primary responsibility is to guard the well-being of the public by seeking to ensure that nurse anesthetists have the necessary knowledge and skills to practice safely and effectively. In so doing, we also protect the value of the CRNA credential. A rigorous national entry process helps assure that those who secure the CRNA credential enter the profession with the knowledge and demonstrated skills necessary to practice, however this is only the first step. Those who earn the credential dedicate themselves to lifelong learning, which ensures continued competence in the specialty.

The continued certification process, developed by the NBCRNA, involves a robust and regular assessment of nurse anesthetist professional practice. NBCRNA regularly assesses the evolving knowledge and continued competencies required in anesthesia health care practice. Our initial certification and continued certification programs meet or exceed the expectations of patients and family members, the requirements of employers, and the demands of regulatory authorities to verify that nurse anesthetists continue to be recognized as providing the safest and best anesthesia care possible. The NBCRNA's autonomy enables us to be objective and credible and helps ensure that the integrity of the CRNA credential cannot be questioned.

THE NBCRNA'S AUTONOMY ENABLES US TO BE OBJECTIVE AND CREDIBLE AND HELPS ENSURE THAT THE INTEGRITY OF THE CRNA CREDENTIAL CANNOT BE QUESTIONED.

Despite a shifting economy and ever-changing job expectations, the strong CRNA credential continues to be recognized as validation of knowledge in the nurse anesthesia profession. CRNA certification creates undeniable value as evidenced by:

- Patients, employers, and regulators recognize that the CRNA credential stands for quality and competence in nurse anesthesia practice, creating numerous opportunities in various practice settings in an ever-changing and evolving health care environment.
- The rigorous and demanding initial education and training, followed by the ongoing continued certification that is required, places nurse anesthetists at the forefront of a growing movement to ensure continuing competency in health care practitioners.

- The high standards for achieving and maintaining the CRNA credential rightly instill confidence among certificants in their professional ability to provide safe, individualized care to the patients they serve.
- Dedication to high standards in certification and continued certification is reflected in the NBCRNA's commitment to ensure that competency evolves consistent with advances in technology and the increasing complexities of patient care. This dedication benefits both patients and nurse anesthetists. Evidence confirms that care provided by nurse anesthetists is of equivalent quality to that provided by physician anesthesia providers. This enviable safety record has led to increasing numbers of opportunities for nurse anesthetists to work independently and has been recognized in lower malpractice premiums.

NBCRNA RESEARCH INITIATIVE: STATE OF THE SCIENCE

As technology and research continue to impact the CRNA practice in the coming years, the NBCRNA is committed to exploring the best ways to assess knowledge as a component of competence. As part of this ongoing work, the NBCRNA Evaluation and Research Advisory Committee (ERAC) established four subcommittees to focus on specific research.

EVALUATION AND RESEARCH ADVISORY COMMITTEE (ERAC) SUBCOMMITTEES



Simulation-Based CPC Assessment Subcommittee

This subcommittee was established to develop a research study on the use of simulation as an alternative to the CPC Assessment (CPCA).



Longitudinal Assessment Subcommittee

This subcommittee was formed to investigate the use of longitudinal assessment as an alternative or option to the CPCA and throughout the NBCRNA's credentialing programs.



Methods to Assess Knowledge and Competence Subcommittee

This subcommittee was formed to explore current and innovative methods for assessment of CRNAs' crucial clinical decision-making knowledge, judgement, and skills throughout their career. These include: Simulation, Longitudinal Assessment, and Virtual Reality – Gaming.

CERTIFYING NEW NURSE ANESTHETISTS SPEAKS TO THE HEART OF THE NBCRNA MISSION TO PROMOTE PATIENT SAFETY THOUGH CREDENTIALING PROGRAMS THAT SUPPORT LIFELONG LEARNING.

RESEARCH-BASED CHANGES TO THE CONTINUED PROFESSIONAL CERTIFICATION ASSESSMENT (CPCA)

In February 2019, the NBCRNA announced two evidence-based changes to the Continued Professional Certification (CPC) Program Assessment component. The NBCRNA conducted both an extensive Beta Research Study on the CPCA, as well as a national Benchmarking Study. After careful consideration of the results and data from those studies, the NBCRNA Board of Directors made the decision to:

1) Remove the pass/fail component of the CPC Program.

The CPCA will still be required every eight years but will remain a performance standard exam only-no pass/fail component.

2) CRNAs will have the option of taking the assessment either remotely at home or place of their choosing, or at a testing center, to provide greater flexibility and choice.

FISCAL YEAR 2019 NBCRNA RESEARCH STUDIES

CPC Assessment Beta Research Study

In Fall 2018, the NBCRNA launched an innovative research study on its computer-based CPC Assessment. The study included 1,500 randomly selected CRNAs who volunteered to take the 150-question, four-hour exam in one of six assigned testing conditions, including with and without resources, and at a testing center or live, remote proctoring. To assure fairness to candidates, psychometricians used statistical equating procedures to place scores from different testing conditions on the same scale.

The study evaluated the testing environments to determine how each may help achieve the goals of the CPC Program in a way that is fair and reliable for all CRNAs completing the assessment requirement which begins in 2020.

Despite varying testing conditions, the percentage of study participants that met the performance standard was 95 percent, indicating preparedness and mastery of the knowledge necessary for practice in nurse anesthesia. The results of the Beta Research Study also demonstrated no difference in the rate at which CRNAs met the performance standard between groups based on the availability of resources.

CPC Assessment Benchmarking Study

The NBCRNA Board of Directors and the ERAC use benchmarking and related reports to continuously evaluate the continued certification requirements, practices, and trends for nursing, and health care and physician credentialing. In 2019, the NBCRNA partnered with a consulting company that specializes in the credentialing field to conduct a national benchmarking study focusing on continuing certification.

The purpose of the Benchmarking Study was to assess the practices, components, costs, and other variables of health care and allied health credentialing organizations' programs accredited by the National Commission for Certifying Agencies (NCCA), the American Board for Specialty Nurse Certification (ABSNC), or the ISO 17024 standards. The data collection tool included 36 variables related to continued certification. The comparative outcomes supported the choice to remove the pass/fail requirement.

This research and the subsequent evidence-based decision process help support the valuable CRNA credential.

NEW RESEARCH TOPICS RESOURCE LAUNCHED

The NBCRNA's ERAC developed a new resource for anesthesia students and practicing CRNAs who are seeking a PhD, DNP, or DNAP on research topics related to CRNA continuing education, certification, and continued certification. Topic categories include: Research, Quality Improvement, Systematic Review, and Clinical and Academic Topics Not Necessarily Related to NBCRNA Data.

NEW VISITING RESEARCH FELLOWSHIP

During Fiscal Year 2019, NBCRNA launched a Call for Applications for a new Visiting Research Fellowship (VRF) Program. This competitive two-year fellowship program stems from the work of the ERAC to provide a fellowship opportunity to CRNAs interested in performing research on professional certification and



credentialing. NBCRNA welcomed the inaugural Visiting Research Fellow (VRF) Nicole-Hymel, DNP, CRNA, MSN, APRN, to the Evaluation and Research Advisory Committee in December 2019, with a term running through August 2021. Dr. Hymel will work with the ERAC on various projects, as well as her own research, which will be featured in future announcements and publications.

LOOKING AHEAD: CPCA PILOT UPDATE

In August 2019, the NBCRNA held a call for participants for a pilot administration of the Continued Professional Certification Assessment (CPCA) to test the process before the CPCA testing window opens. The NBCRNA received an overwhelming response, with 3,060 qualified participants for 800 spots. Pools of 400 candidates per testing environment were created, one group was selected for a Remote Record and Review testing condition, and a second group was scheduled to take the assessment at a testing center. The final participants selected were representative of the CRNA population (using key demographic characteristics representative of the general population). The pilot testing period will begin in 2020.

THE CONTINUED PROFESSIONAL CERTIFICATION (CPC) PROGRAM

The Continued Professional Certification (CPC) Program is designed to promote lifelong learning, help Certified Registered Nurse Anesthetists maintain the currency of their anesthesia knowledge and improve patient safety. During Fiscal Year 2019, the multi-modal NBCRNA CPC Program entered its third year.

Each year, candidates in the **122 nurse anesthesia programs** throughout the United States sit for the National Certification Exam (NCE) to become Certified Registered Nurse Anesthetists (CRNAs). The CPC Program then continues to carry out its mission of protecting patient safety through continuing education requirements for the practicing CRNA. Today there are more than **55,700 CRNAs** practicing throughout the United States in every practice setting.

CPC PROGRAM CONTINUED PROFESSIONAL CERTIFICATION

The CPC Program is based on an 8-year period, and each period is comprised of two 4-year cycles. At the mid-point of every four years, CRNAs check in through a simple online process known as the 2-year Check-In, renew certification at the 4- and 8-year mark, and take an assessment by the end of the 8-year period (not pass/ fail). CPC PROGRAM NATIONWIDE OUTREACH

The NBCRNA is committed to ensuring all CRNAs have information to help understand the CPC Program and its components. The NBCRNA continued its initiative to provide information on the CPC Program through live presentations to CRNAs across the country at state, vendor, and institution meetings, as well as through live webinars and distributed materials. Additionally, the NBCRNA launched an Ambassador Program to provide an organized way for CRNAs to share CPC information and resources with their colleagues.

The CPC Program educational outreach delivered 60 live presentations in 34 states from September 1, 2018, through December 31, 2019. ADVANCING THE PROFESSION: INITIAL CERTIFICATION

SELF-EVALUATION EXAMINATION (SEE)

The NBCRNA Self Evaluation Exam (SEE) is an important part of the preparatory process on becoming a CRNA. The SEE is a voluntary examination with three objectives: to provide information to students about their progress in the nurse anesthesia educational program; to provide information to program administrators on how well their programs are preparing students with the knowledge they need for anesthesia practice; and to prepare students for the National Certification Examination (NCE) experience.



A total of **6,309** Self-Evaluation Examinations (SEE) were administered between September 1, 2018, and December 31, 2019.

SEE Predictability

The 2019 Report on Preliminary Evaluation of the Reconfigured Self-Evaluation Examination showed that there is a moderately high, positive correlation between SEE scores and eventual performance on the first NCE attempt.

NATIONAL CERTIFICATION EXAMINATION (NCE)

Each year, candidates in the **122 nurse anesthesia programs** throughout the United States sit for the National Certification Exam (NCE) to become Certified Registered Nurse Anesthetists (CRNA). The NCE is a variable-length computerized adaptive test administered to measure the knowledge, skills, and abilities necessary for entry-level nurse anesthesia practitioners. A list of newly certified CRNAs by state of residence is published monthly on the NBCRNA website.

NCE/SEE Item Copyright Secured

In 2019, NBCRNA secured registration of NCE and SEE exam items (exam questions). In June 2017, the U.S. Copyright Office issued a rule that changed how secure test items may be registered for copyright. In general, test forms assembled by a computer during test administration (such as the NCE and SEE) could no longer be designated secure tests. In November 2017, Copyright modified its rule, allowing for group registration of individual secure test items. NBCRNA used this process to submit large redacted sets of items in May 2018. With the backlog at Copyright, NBCRNA received an appointment with Copyright examiners in Washington, DC, in February 2019, and later received final certificates of registration. NONSURGICAL PAIN MANAGEMENT (NSPM-C) CERTIFICATION

Since the NBCRNA developed the voluntary subspecialty certification program for nurse anesthetists in Nonsurgical Pain Management (NSPM-C), the number of individuals pursuing the program has grown, demonstrating interest in the subspecialty. The NBCRNA's NSPM program was initially developed in 2015 in response to challenges continually faced by nurse anesthetists who practice nonsurgical pain management. It measures the knowledge, skills, and abilities of CRNAs for practice in the field of nonsurgical pain management. The NSPM-C program is accredited by the National Commission for Certifying Agencies (NCCA) and the Accreditation Board for Specialty Nursing Certification (ABSNC).

Since inception of the NSPM program through December 31, 2019, **77 CRNAs** now hold the NSPM-C credential, **26** of which were achieved during 9/1/2018 – 12/31/2019.
