Nurse Anesthetist Certifying Board Names New Chief Credentialing Officer Christopher Gill, PhD, MBA, CRNA

Dr. Gill was selected following a nationwide search for this position. He succeeds John Preston, DNSc, CRNA, FNAP, APRN, who was named NBCRNA Chief Executive Officer in April 2021.
