Tim Muckle, PhD, Rejoins NBCRNA as Chief Assessment Officer

CHICAGO – June 10, 2021 – Tim Muckle, PhD, has been named Chief Assessment Officer for the National Board of Certification and Recertification for Nurse Anesthetists (NBCRNA). Prior to returning to the NBCRNA, Dr. Muckle most recently served in the role of Senior Director, Psychometrics and Testing, with the Board of Pharmacy Specialties.

As my connection with the organization goes back to 2002, I consider NBCRNA my professional home, so I am excited to return at this pivotal time for the organization," said Dr. Muckle.
